**1. Brief facts of the complaint**

Shri Bane Singh had filed a grievance in PGC on 04.04.2019 regarding nonpayment for the work done by him with DEMS, South Zone.

**2. Proceedings in the Public Grievances Commission**

The PGC has convened nine hearings in the matter so far and in the hearing held on 07.01.2020, the following are present:

**3. Relevant facts emerging during the hearing**

3.1 Sh. R.K. Sharma, Inspector, Vigilance Deptt., SDMC is present in the hearing and submitted a Status Report stating that "Investigation in the matter has been conducted by Vigilance Department and the records pertaining to the case were called from the zonal office. As per the records provided by the Sanitation Department, SZ, it is informed that the full and final payment of Rs.3,33,000/- has been made to the contractor on 18.11.2019. Moreover, as per the records, it has been observed

that the case has been dealt with by Sh. K.C. Bhardwaj, CSI/SS and Sh. Iqbal Singh, SS. The statement has also been recorded in the Vigilance department and they have been primarily found responsible for delay and a report has been sent to the Competent Authority for taking a decision in the matter.”

**4. Recommendations of the PGC :**

As the complainant has been paid off his dues and the Vigilance Department has submitted a report to the Competent Authority for taking a decision in the matter, the case stands closed at the level of this Commission.
