1. Brief Facts of the Case

1.1 Sh. Rejimon CK has filed a complaint in PGC on 22.10.2019 regarding serious complaint against Sh. B.S.Thakur ,Dy. Registrar, Mr. K.P.Suhag (Asstt. Registrar and Mr. M G Satya AR Vigilance.

1.2 The complainant is not present.

2. Facts emerged during the hearing

1.1 The complainant in his grievance had stated that Mr.B.S. Thakur, Dy. Registrar who were charge sheeted for corruption and notorious for various corrupt activities in various societies, with conflict of interest and what not, reject this appeal based on claiming to be a letter from society while no copy of the said letter provided. The rejection for the same was stated a appellant is not primary member. Nowhere in the RTI application appellant mentioned that he is primary member. The RCS records of register, membership certificate, documents

and list of RCS itself confirmed and forward to other agencies including DDA Group Housing confirm Mr. Rejimon CK is joint member as per section 23 of DCS Act 2005.

1.2 Sh.Parteek, ASO from RCS was present in today's hearing and has filed an ATR stating therein that "it is pertinent to mention that Shj. Rejimon CK is a habitual complainant in this office, allegedly complaining against many senior officers also. Since, he has multiple complaints against many officers of this office, he has also been informed through multiple platforms earlier also to personally visit the office for submitting the complaints so that these can be resolved but to no avail.

Further Sh. Prateek has submitted a letter dt. 2.9.2019 from Nav Sansad CGHS Ltd., stating that Mr. Rejimon CK is not a primary member of the society and hence not entitled to get RTI replies. Accordingly, Dy. Registrar has also issued an order vide no. DR/R/S/139/14/272/2019/949-949 dt. 27.9.2019 in this regards. This letter has been taken on record by the Commission.

2. Directions of PGC

2.1 The Commission advises the Registrar, Cooperative of Societies to personally get examine the grievances of the complainant and resolve the issues.

2.2 With the above advises the Commission has decided to close the case.
