**1. Brief facts of the complaint**

Sh. Chakresh Kumar had filed a grievance in PGC against Mr. Mohd. Abrej Alam who is running transport business illegally from property No. 7767/1A, Gali No.2, Ram Nagar, Pahar Ganj, New Delhi – 110055.

DC (CSPZ)/Bldg.-(Misuse)/2019/D-131 on 04.12.2019. Now, the occupier/owner of the property in question i.e. Shop no. 7767/1A, Gali No.2, Ram Nagar, Pahar

Ganj, Delhi has stopped the said commercial activity and vacated the premises under question. Photographs enclosed.”
