1. Background

Shri Vivek Bansal, the appellant vide his application dated 15/09/2018 under Delhi Right to Information Act, 2001, had sought information from the Competent Authority on 18 points.

Being aggrieved with non receipt of any information, he filed this appeal before the Commission.

2. Proceedings

The appellant is present and heard.

Shri P.K.Sharma, AE (B), II, KPZ, North DMC, is present on behalf of the Competent Authority. The departmental representative informs that pointwise information has already been provided to the appellant by the department vide letter dated 15/01/2019. He submitted a copy of the same in the hearing today.

The information provided by the department has been perused and it appears that the department has provided satisfactory information to all the queries of the appellant, except for query no. 5.

In response to query no. 5, the department has informed that Shri B.P.Singh and Shri Mukesh Meena are presently the AE & JE of the area concerned but the other information does not come under the purview of DRTI Act. This reply of the department is not correct and hence, not acceptable. The names of AE (B) and JE (B) of the area for the last one year may be provided to the appellant.

In response to query no. 17, the department has mentioned that the appellant may deposit Rs. 290/- for obtaining photocopies of 58 pages of the Misal Bandh Register. The appellant is advised to deposit the amount within 7 days of receipt of this order.

3. Decision

Since the Competent Authority has furnished satisfactory information to all the queries of the appellant, except for query no. 5, no further action is required to be taken by the department on these queries.

In respect of query no. 5, the Competent Authority shall furnish a revised reply as advised above. The revised reply shall be sent under the signature / stamp of the Competent Authority directly to appellant, with a copy marked to this Commission for information, within 10 days of receipt of this order.

In respect of query no. 17, the appellant is advised to deposit Rs. 290/- for obtaining the photocopies of the documents sought by him in his DRTI application.

Though it is not part of DRTI appeal under consideration, the Deputy Commissioner (Keshav Puram Zone), North DMC, is advised to initiate appropriate action against the property bearing no. 38, Kailash Enclave, Pitampura, which has been booked for "*unauthorized construction in the shape of entire basement on 26/06/2018*". An Action Taken Report may be submitted in the Commission for perusal.

In view of above, **the appeal case is ordered to be closed before the Appellate Authority / PGC.**
