**1. Brief Facts of the Case**

1.1 Sh.T.K.Jain filed a grievance in PGC on 04.11.2019 regarding resumption of execution proceedings of award bearing no. 6892 /ARB/2004-05 dt.27.6.2004 against Sh. Anoop Kumar Bakshi membership no. 26, flat No. B-48.

**2. Facts emerged during the hearing**

2.1 Sh. Tanuj Bhanot, Asstt. Registrar is present on behalf of the department and stated that ATR was filed by the department on 16.12.2019 stating therein that "*the execution proceedings award bearing no. 6892/ARB/2004 is pending in the Court of Assistant Collector. Since the matter is sub-judice in the Court of Asstt. Collector hence therefore no decision in the matter could be taken right now.*"

2.2 He further stated that the Management Committee has already resigned. Election will be held in due process. Once election is held and duly constituted Management Committee take charges, then action can be taken.

2.3 The Commission observes that the matter is sub-judice and nothing can be done at this stage. Sh.Tanuj Bhanot, Asstt. Registrar, RCS office is present in the hearing today and stated that election is still not held in the said society. In due process election will be held and new committee is constituted then recovery notice will be sent to the Committee Members. The process is to be completed in due course of time and if some grievances are still pending and recovery is not done, the complainant is free to approach the Commission or other channels for his legal remedy.

### 3. **Directions of PGC**

3.1 The case is subjudice in the Court of Asstt. Collector, hence Commission cannot intervene as per mandate of PGC. Accordingly the case is disposed off.
