**1. Brief facts of the complaint**

1.1 Ms.Vinita Kher has filed a grievance in PGC on 01.11.2019 regarding family pension to her mother Mrs. Nivedita Dave (widow of late Sh. P.S. Dave, IAS) through PPO 623767900167.

**2. Facts emerged during the proceedings**

2.1 Sh. Aditya Dave, son of Mrs. Nivedita Dave (widow of late Sh. P.S. Dave, IAS) informed that his mother is getting family pension through PPO No. 623767900167. She is 90 years of age and has been bedridden for some years and is in constant need for medical and other maintenance. Her grievance is that:- (1) The addition of 6<sup>th</sup> and 7<sup>th</sup> pay Commission allowance to her pension. (2) the addition of the pension raise as per 80 years, 85 years and now 90 years.

2.2 Sh. Sanjay Kumar Gupta, Dy. Labour Commissioner is present in the hearing and has submitted a letter addressed by Ms. Anita Rana, Dy. Labour Commissioner (Admn.) to Sh. Aditya Dave, son of Mrs. Nivedita Dave dated 15.07.2020, stating therein that *“the pension in r/o late Smt. Nivedita Dave, w/o late Sh. P.S. Dave, IAS has been revised upto 24.11.2019. You are therefore requested to follow up the matter with the concerned bank/branch for further adjustments of dues/arrears, if any.”*

2.3 Sh. Sanjay Kumar Gupta, Dy. Labour Commissioner present in the hearing stated that since Mrs. Nivedita Dave passed away on 24.11.2019 (as intimated by her son Sh. Aditya Dave to PAO – VI vide letter dated 10.12.2019), the pension in respect of Mrs. Nivedita Dave, w/o late Sh. P.S. Dave, IAS has been revised upto 24.11.2019. Therefore, Sh. Aditya Dave may contact the concerned bank branch (where the family pension in respect of late Sh. P.S. Dave, IAS got credited) for any further adjustments of dues or arrears.

**3. Directions**

3.1 The case stands disposed of in the Commission as the pension in respect of late Mrs. Nivedita Dave, w/o late Sh. P.S. Dave, IAS has been revised upto 24.11.2019 and no action appears to be pending on the part of the Labour Department. Further, the complainant is at liberty to approach the Labour Department as well as the Commission in case he has any further grievance with regard to his present complaint.
