1. Brief facts of the case

1.1 Mr. John Panicker, has filed a grievance petition before Public Grievances Commission, against owner of House No.202-B, First Floor, LIG DDA flat, Motia Khan, Paharganj, Delhi for non-repairing of sewerage water line bursted leaking which is emanating foul smell in his House No.202-A, LIG DDA Flats, Motia Khan, Paharganj, Delhi-110055.

2. Facts emerged during the proceedings.

2.1 An action taken report has been filed on behalf of EE(Central)-II, Delhi Jal Board, stating that "*There is seepage problem in the complainant's house from upper floor and the complainant wants that the water connection of the upper floor is disconnected to sort out this problem. The concerned staff has already expressed inability to do so to the complainant who is advised to take up the matter with DDA as these quarters are maintained by that department.*"

2.2 The complainant is not present.

3. Directions :

3.1 In view of the submissions made by the Zonal Engineer, DJB, the case of the complainant stands dismissed as it is beyond the jurisdiction of the respondent department.
