- 3.3 Sh.Vijay Yadav, PHI is present in the hearing and submitted a report from DHO, Rohini zone stating that:

"The Public Health Department takes action against vendors selling eatables and drinks exposed to dust and flies. The matter of removal of unauthorized temporary and permanent encroachment (khokhas) from footpath pertains to General Branch and Engineering Department."

#### 4. Recommendations of the PGC

Sh. Dinesh Sharma, Admn. Officer, Rohini Zone is advised to direct the field staff to keep a vigil in the area so that the encroachment, once removed do not reoccur.
