1. Brief facts of the complaint

Sh. Rajan has filed a grievance in PGC regarding encroachment on footpath opposite H-Block, Market No. 2, Mangol Puri and non action by the officers of Rohini Zone, North DMC.

2. Proceedings in the Public Grievances Commission

The PGC has convened three hearings in the matter so far and in the hearing held on 30.09.2020, the following are present:

3. Relevant facts that emerged during the hearing

3.1 Shri Deepak Kumar, ASO, Rohini Zone is present in the hearing and submitted a status report from Sh. Dinesh Sharma, A.O. stating that :

3.2 Sh. Raj Kumar Singh, SO/H is present in the hearing informed that the park which belongs to Horticulture Department is free from encroachment.

3.3 Sh.Vijay Yadav, PHI is present in the hearing and submitted a report from DHO, Rohini zone stating that:

“The Public Health Department takes action against vendors selling eatables and drinks exposed to dust and flies. The matter of removal of unauthorized temporary and permanent encroachment (khokhas) from footpath pertains to General Branch and Engineering Department.”

4. Recommendations of the PGC

Sh. Dinesh Sharma, Admn. Officer, Rohini Zone is advised to direct the field staff to keep a vigil in the area so that the encroachment, once removed do not reoccur.

With the above directions the matter stands closed at the level of the Commission.
