**1. Brief facts of the case**

1.1 Ms.Gunjan Ghai, complainant, has filed a grievance petition before Public Grievances Commission, complaining against ongoing illegal water connection taken in Khushi Ram Park, House No.8 & 9. She further stated in her petition that a complaint has been made to local JE for that but they are also incapable of stopping them from doing illegal water connection. Furthermore, said persons neither live in Om Vihar nor they have right to take water connections from there.

**2. Facts emerged during the proceedings.**

2.1 A report has been received on 07.10.2020 from ZRO(SW)-I, Delhi Jal Board. Details of 08 functional water connections have been mentioned in the report as follows:
