1. Brief Facts of the Case

Shri Ram Narayan Kashyap & Ors. have filed a complaint in the Commission on 29.8.2018 requesting the intervention of the Commission to resolve their long pending issue of ACP/MACP by the Services Department, GNCT of Delhi.

2. Facts emerged during the proceedings

Shri Niraj Sinha, Senior Assistant from ACP Cell (Services Department) is present and submitted Action Taken Report under the signature of Shri Shiv Shankar umar, Section Officer (ACP) Cell, stating the following :-

Shri Ram Narayan Kashyap, Retd. Senior Assistant and others have already been granted 2nd ACP/MACP benefits.

Further, the 3rd MACP case in respect of Shri Mohan chand, Shri Baldev Prashad, Shri Vijay Kumar Saxena, Shri Shekharanand alongwith other officials re-deployed from DEDA/DSMDC was placed before the designated Screening Committee and after acceptance of recommendations of Screening Committee by Competent Authority, 3rd financial upgradation under MACP Scheme has been granted to the complainants vide orders No. 127 & 128 dated 16.9.2020.

Administration Department of these officials have been requested to take necessary action for release of 3rd MACP benefits.

3. Directions of PGC

3.1 **The Medical Superintendent, GTB Hospital, the Controller, W&M Department, the Director, Dte. Of Education and the Commissioner Transport** is requested to release the benefits of 3rd MACP to Shri Shekhranand, UDC (Retd.), Shri Vijay Kumar Saxena, UDC (Retd.), Shri Baldev Prasad, Retd. UDC and Shri Mohan Chand, UDC (Retd.) expeditiously to resolve their long pending grievance in the Commission. Further, this Commission be informed once the 3rd MACP benefits are released to aggrieved retired officials.

3.2 With the above directions, the Commission has decided to close the case in PGC.
