**1. Brief Facts of the Case**

1.1 Smt. Kanta Devi filed a grievance in PGC regarding non-allotment of flat in Talaganj Cooperative Group Housing Society Ltd. inspite of the directions of the Hon'ble High Court by the Office of Registrar, Cooperative Societies, Govt. of NCT of Delhi.

**2. Facts emerged during the proceedings**

2.1 Sh. Chhabil Singh, Asstt. Section Officer, Office of Registrar Cooperative Societies was present in the hearing and furnished a letter dated 08.08.2019 from Sh. Gulshan Ahuja, Asstt. Registrar (Sec.-8) to the Dy. Director (GH), DDA and the same is taken on record stating that "*Ms. Kanta Devi (M.S. No.432) has filed a writ petition in the High Court in WP (C) No.6811/2013 for clearance of membership for allotment of flat. The High Court vide order dated 15.02.2019 has directed to proceed further in the matter and requisite steps be taken within 04 weeks. In view of court directions, the membership clearance case of Smt. Kanta Devi (M.S. No.432) was placed before the Rule 90 Committee on 30.05.2019 and the Committee has cleared her membership as per details given under:-*

*It is therefore requested to conduct draw of lots for allotment of flat."*
