# Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97

### 1. Brief facts of the complaint

Sh. Mohit Aggarwal has filed a grievance in PGC on 06.03.2018 stating about the encroachment on public land / DDA land, in toilet and also in the whole DDA market, JD Block, Pitampura & boundary wall in backside of the market which has been demolished by miscreants.

### 2. Proceedings in the Public Grievances Commission

The PGC has convened nineteen hearings in the matter so far and in the hearing held on 06.10.2020, the following are present:

### 3. Relevant facts that emerged during the hearing

3.1 Sh. Jitender Kumar, Asstt. Engineer (M), Keshav Puram Zone is present in the hearing and submitted a status report stating that:

"In continuation of earlier report, it is submitted that site has been inspected again and found that there is no permanent encroachment at site relates to maintenance / works department.

Therefore, it is requested that the grievance may please be concluded on the part of Maintenance Department."

3.2 Sh. Ashok Kakarwal, JE (B-I)/KPZ is present in the hearing and submitted a Status Report from Ex. Engineer (B) stating that: "No demolition action is required further against the illegal construction existing in above mentioned property as all illegal construction has been removed already except the unauthorized construction existing in shop No. 5 & 6 (ground floor) of DDA market, JD Block, Pitampura, Delhi against which stay has been granted by Hon'ble Court of ATMCD. The action on these shops will be taken after vacation of stay in Hon'ble Court of ATMCD. "

3.3 Sh. Jitender Kumar, AE(M) present in the hearing further informed that as per lease deed, with the owners of the properties, the area has been measured and all encroachments have been removed. As regards the construction of toilet is concerned the same will be constructed once the funds are made available to them.

#### 4. Recommendations of the PGC

As action in the matter has been taken by Maintenance as well as Building Department of Keshav Puram Zone, the same stands closed at the level of the Commission.
