**1. Brief facts of the complaint**

1.1 Sh. P Swaminathan has filed a grievance petition before Public Grievances Commission, aggrieved by non-revision of his pension based on ACP-II and for release of arrears of the same. It is stated in his complaint that he is drawing the same pension as before the CPCs.

**2. Relevant facts emerging during the hearing**

2.1 Shri B.B. Gupta, Dy.Director of Education, Zone-28, GNCT of Delhi as well as representative of the School filed an action taken report. It is stated that ACP-II arrears have been received by Sh.P. Swaminathan on 30.11.2015 and his pension has been revised as per VIIth CPC by Pay & Accounts Office. Further, the allegations made by Sh.P. Swaminathan, Retd.PET in his representation are found to be untrue.

2.2 The complainant is not present.
