1. Brief facts of the complaint

1.1 Sh. Ish Kumar filed a grievance petition before the Public Grievances Commission aggrieved by non-fixation of his pay in the Grade Pay of Rs.4600/- instead of Rs.4200/- w.e.f. 01.01.2006. It is further stated that in the same manner, his pay will be refixed/revised in grant of his II MACP w.e.f. 17.10.2010 in Grade Pay of Rs.4800/- instead of Rs.4600/-. He requested for Commission's intervention for direction to the respondent department to take needful action in the matter.

2. Relevant facts emerging during the hearing

2.1 Shri Avtar Singh Rawat, School In-Charge, Dhanpatmal Virmani Sr.Secondary School, Delhi-110007 filed a report stating that the "*Grievances of Sh.Ish Kumar (Ex-Head Clerk) has been resolved and all desired amount credited in his account and same had confirmed by Sh.Ish Kumar telephonically.*"

3. Directions of the PGC

3.1 In view of the action taken by the School Authorities/respondent department in redressing the grievances of the complainant, the case stands disposed of in the Commission.
