**1. Brief facts of the case**

1.1 Shri S.P. Gupta, National President, All india Samaj Sewa Dal, (complainant), has filed a grievance petition before Public Grievances Commission, complaining against the works executed under Executive Engineer Central-II, Delhi Jal Board and demanded a probe through CBI. He pointed out certain discrepancies and use of inferior quality work/material in the name of improvement and replacement of sewer line and water line etc. He also requested that the investigation should be conducted and two representatives of his Dal be included in the investigation team.

**2. Facts emerged during the proceedings.**

2.1 Shri P. Pant, Executive Engineer(Central)-II, Delhi Jal Board, GNCT of Delhi filed an action taken report. It is stated in the report that "*A close examination of the complaint made by Shri S.P.Gupta, R/o. Office A-71, Shastri Nagar, New Delhi-110052 shows that the allegations made in the complaint are general and not specific in nature. Prima facie, the complaint is made on the basis of surmises and not facts.*"

2.2 The Complainant is not present.

**3. Directions :**

3.1 In view of the submissions made by the Executive Engineer(Central)-II, Delhi Jal Board, the Commission feels that the complaint is frivolous and general in nature. Moreover, the complainant is not present in the Commission to support his contention. Hence, the petition of the complainant is dismissed. The complainant is

debarred from filing such frivolous complaints in future which would not be entertained as such petitions waste the time of the Commission as well as the officers of the respondent departments.
