1. Brief facts of the case

1.1 Shri Bhupender Singh has filed a grievance petition before Public Grievances Commission, aggrieved by non-payment of pension & pensionary benefits by the Dte.of Social Welfare, GNCT of Delhi. He has requested for Commission's intervention for direction to the respondent department for taking prompt needful action.

2. Facts emerged during the proceedings.

2.1 An ATR has been filed on behalf of Sh. Shiv Narayan Singh, Supdt/HOO, HMB(A&D), Deptt. of Social Welfare, GNCT of Delhi. It has been stated by him that :-

"i) Payment of GPF for Rs.4,71,574 & payment of UTGEIS for Rs.1,26,213/- has been paid.

ii) Payment of DCRG for Rs.16,67,210/- has been paid.

- iii) Payment of Pension arrear w.e.f. 01/09/2018 to 30/11/2019 for Rs.7,84,710/- has been paid.
- iv) Leave Encashment of Rs.9, 17,807/- has been paid.
- *v)* 3rd MACP and Annual Increment w.e.f. 01.07.2009 has been granted and arrear of the same has been paid.
- vi) Revised Leave Encashment amount of Rs.67,326/- has been paid.
- vii) Regularised the suspension period from 26.11.2008 to 21.8.2009 as "period spent on duty" with full pay & allowance' vide MHA, GOI, order dated 05.10.2020 duly forwarded by Dte.of Vigilance, GNCTD."

2.2 A letter dated 16.10.2020 from Assistant Director(Vigilance), GNCT of Delhi is on record enclosing therewith a copy of order dated 05th October, 2020 of MHA, GOI with regard to regularization of suspension period from 26.11.2008 to 21.08.2009 as "period spent on duty with full pay and allowances" in respect of Sh. Bhupinder Singh, the then ad-hoc DANICS.

2.3 The complainant is not present. However, he has sent a email on 08.11.2020 stating that he will not be able to attend the proceedings due to weakness because of CORONA.

3. <u>Directions</u>

3.1 In view of the action taken report and submissions made by the representative of the repondent department, the case of the complainant stands disposed of in the Commission.

3.2 The complainant is advised to inform the respondent department as well as the Commission in case any of his grievances, as mentioned in his petition, has remained unattended or unresolved by the respondent department.
