ORDER

Whereas, Jhang Co-operative Group Housing Society, Plot No. – 40, Sector- 13, Rohini, Delhi - 110085 is registered vide Registration No. 505 with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the Society.

And whereas, this office had appointed Sh. Manoj Kaushik as Returning Officer u/s 35(1) of DCS Act, 2003 to conduct the election of Jhang CGHS Ltd. vide this office order dated 25.03.2019.

And whereas, Sh. Manoj Kaushik, Returning Officer has submitted his resignation from the post of Returning Officer in Jhang CGHS Ltd. citing workload in his parent office and expressed his inability to continue as R.O.

And whereas, the tenure of the present Managing Committee of the Society has been expired on 09.04.2019.

And whereas, on expiration of tenure of the Managing Committee, the appointment of Administrator – cum – Returning Officer is required as per section 35(5) of DCS Act, 2003 which says that:-

Election and nomination of members of committee.

(5) Thereafter the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and the affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election within ninety days from the date of his appointment.

And whereas, in view of the above circumstances, the Registrar Cooperative Societies has directed to appoint Sh. Yashpal Kaushik, Jt. Secy., Deptt. of Budget, as Administrator-cum-Returning Officer in the aforesaid Society u/s 35(5) of DCS Act, 2003.

Now therefore, I, Ajit Kumar, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Yashpal Kaushik, Jt. Secy., Deptt. of Budget, as Administrator-cum-Returning Officer in Jhang Co-operative Group Housing Society under section 35 (5) of DCS Act, 2003 with immediate effect to conduct the election of the Managing Committee of the society within 90 days from the issue of this order and to attend day to day affairs of the society.

He will be paid Rs. 10,000/- (Rupees Ten Thousand Only) per month as honorarium from the society's fund for this purpose from the date of taking over the charge.

This issues with the prior approval of the Competent Authority.
