**ORDER**

Whereas, the Garhwal Cooperative Group Housing Society Ltd., Community Hall, Mandakini Apartments, Pitam Pura, New Delhi, is registered vide registration No.106/GH with this department under the provisions of DCS Act & Rules framed there under;

And whereas, a complaint was received from the Secretary, Garhwal CGHS Ltd. to hold an inquiry in regard to mismanagement and financial irregularities committed between 2013-2018 by the previous MC, which include irregularities in enrolling new members.

And whereas, the matter was examined and after taking into consideration the contents of the complaint, it was decided by the Competent Authority to appoint an Inspecting Officer u/s 61 of DCS Act, 2003 to inspect the records, books of accounts, vouchers, security, stock and other property of the Society.

Now therefore, I Ajit Kumar, Assistant Registrar (Section-III) (Housing) hereby convey the approval of Competent Authority to appoint Sh. Yash Pal Kaushik, Joint Secretary, Finance Department, GNCT of Delhi as Inspecting Officer under Section 61 of DCS Act, 2003. Further, the society shall pay Rs. 15,000/- (Rupees Fifteen Thousand Only) as remuneration to the Inspecting Officer from the fund of the society for conducting the inspection on the above allegations. The inspection shall be completed within a period of 60 days of issue of this order.
