ORDER

Whereas, Indian Statistical Institute Co-operative Group Housing Society Ltd., Plot No. 07, Co-op. Group Housing Societies Complex, Dhirpur Phase-I, Delhi-110009 is registered vide Registration No.870/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, the Secretary of the Society has requested this office to appoint a Returning Officer.

And whereas, the Delhi Cooperative Societies Act, 2003 has come into force with effect from 01.04.2005 vide notification dated 24.03.2006. As per the provision of Section 35(1) of DCS Act, 2003 the entire process of the election of the Managing Committee of the Co-operative Societies shall be conducted by Returning Officer to be appointed by the Government who shall not be below the Rank of Gazetted Officer.

And whereas, in exercise of the powers vested under Section 35(1) of DCS Act, 2003, the Competent Authority has approved that the election of the society shall be managed by Returning Officer.

Now therefore, I, Ajit Kumar, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Janardan Prasad, Section Officer, Returning Officer in Indian Statistical Institute Co-operative Group Housing Society Ltd. (Regn. No. 870/GH) under section 35 (1) of DCS Act, 2003 to conduct the election of the Managing Committee as per DCS Act & Rules.

He will be paid Rs.6,000/- (Rupees Six Thousand Only) as remuneration from the society's fund for this purpose.
