Whereas, The Jyoti Raw Phooley Co-operative Thrift & Credit Society Ltd-. F-144, Gali No.-2, Ganga Vihar, Delhi – 110 094 is registered with this department at Regn. No. 04TC/NE under the provisions of DCS Act and Rules.

Whereas, on the complaint of Sh. Brijesh Kumar, President of the society vide this office order dated 14/11/2018 Sh. Kishore Kumar Bhalla (Retd. AC) was appointed as Administrator-Cum-RO in the said society with the direction to conduct the election of the MC of the society as per provision of DCS Act & Rules 2007 and submit the inquiry report on the complaint received from the President.

Whereas, vide letter dated 20/05/2019 Sh. Kishore Kumar Bhalla has submitted the inquiry report on the above mention compliant wherein we has submitted that election of the committee are proposed to be held in the last week of June, 2018.

Whereas, on 31/07/2019 due to some circumstances prevailing in the society and the distance factor he resigned from the society.

Further vide order dated 14/10/19 Sh. Tapan Jha, Dy. Secy.(L&B) was appointed as Administrator-Cum-Returning Officer u/s 35(5) DCS Act 2003, who was resigned on 27.11.2019.

Now, therefore, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi in exercise of the power vested in her under DCS Act & Rule, is pleased to appoint Sh. K.S.Meena, Addl. Commissioner(Disaster Management) as Administrator – cum Returning Officer U/s 35(5) of DCS Act. 2003, to conduct the election of the society within 90 days. An honorarium of Rs. 10,000/- (Rupees Ten Thousand Only) per month plus conveyance will be paid to him for this purpose out of the society funds.
