And whereas, a complaint was received from Sh. B. S. Dahiya and 03 other members of the Home Living CGHS Ltd. to hold an inquiry in regard to mismanagement of affairs and mis-appropriation of the funds of the society

And whereas, the matter was examined and after taking into consideration the contents of the complaint, it was decided by the Competent Authority to appoint an Inspecting Officer u/s 61 of DCS Act, 2003 to inspect the records of the Society.

Now therefore, I Ajit Kumar, Assistant Registrar (Section-III) (Housing) hereby convey the approval of Competent Authority to appoint Sh. Vinay Kaushik, Deputy Secretary, Delhi Building & others Construction Worker's Welfare Board, as Inspecting Officer under Section 61 of DCS Act, 2003. Further, the society shall pay Rs. 15,000/- (Rupees Fifteen Thousand Only) as remuneration to the Inspecting Officer from the fund of the society for conducting the inspection on the above allegations. The inspection shall be completed within a period of 60 days of issue of this order.
