ORDER

Whereas, ILA Cooperative Group Housing Society Ltd., B-7, Vasundhara Enclave Delhi-110096, is registered vide registration No.372-GH with this department under the provisions of DCS Act & Rules framed thereunder.

And whereas, a complaint was received from Smt. Nargis Aggarwal and some other members of ILA CGHS Ltd. to hold an inquiry in regard to financial irregularities/misappropriation of fund and violation of Society bye-laws while installing the CCTV Cameras in Society, installation of water borewell on much higher price than the actual price, substandard repair work that too on higher prices, use of contingency fund without following the due process, improper functioning etc.

And whereas, the matter was examined and after taking into consideration the contents of the complaint, it was decided by the Competent Authority to appoint an Inspecting Officer u/s 61 of DCS Act, 2003 to inspect the records of the Society.

Now therefore, I Ajit Kumar, Assistant Registrar (Section-III) (Housing) hereby convey the approval of Competent Authority to appoint Sh. Chandan Sengupta, Deputy Secretary, CM Office, as Inspecting Officer under Section 61 of DCS Act, 2003. Further, the society shall pay Rs. 15,000/- (Rupees Fifteen Thousand Only) as remuneration to the Inspecting Officer from the fund of the society for conducting the inspection on the above allegations. The inspection shall be completed within a period of 60 days of issue of this order.
