ORDER

Whereas, Friends (MGO Branch) Co-operative Thrift & Credit Society Ltd., Room No.190, C-II, Hutments, Dalhouse Road, New Delhi-110011 is registered with this department at Regn. No. 934C-TC under the provisions of DCS Act and Rules.

Whereas, last election of the society was held on 23/12/2016. Its elected President, Vice President, Secretary & other office bearers were subsequently resigned from the respective post due to superannuation from service.

Whereas, to conduct the election of the Managing Committee, the Hony. Secretary, has appointed a Returning officer and he has served notice on 28 Mar 2018 for conducting election for the new office bearers. However, no member had filled nomination.


Whereas, in Jun 2019 the existing treasure has retired and subsequently for carrying out day to day function of the Society, existing executive member Shri V Gopalakrishnan took over the charge of Hony. Secretary and the existing Hony. Secretary Shri Rajagopal has took over the charge of Hony. Treasurer Wef 01 July 2019.

Whereas, In May 2019 Hony. Treasurer Shri Rajagopal has retired from service and he has given temporary security entry pass upto 31 August 2019. And he has worked as Hony. Treasurer upto August 2019. Since the Society is functioning from the Defence Security Zone, he is not permitted to enter the Society Office. Subsequently the Hony. Secretary also submitted his resignation from the post and proceeded on leave to his home town to carry out his urgent family issues. In the month of September 19 the Society Office was not opened and so the members were unable to pay their monthly CD and loan instalments.

Whereas, since no governing body of the society is there to carry out day to day function of the society. Sh. Rajagopal C, Hony Treasurer of the society has requested to appoint Administrator in the society to carry out day to day function of the society and safeguard the deposits & interest of the society and also take over the society.

Now, therefore, the Registrar Co-operative Societies, GNCT of Delhi in exercise of the power vested with him under DCS Act & Rule, is pleased to appoint Sh. G.S.Kohli, Retd. Excutive Engineer NDMC, as Administrator-cum-Returning Officer U/s 35(5) of DCS Act. 2003, to conduct the election of the society within 90 days. An honorarium of Rs. 10,000/- (Rupees Ten Thousand Only) per month plus other charges will be paid to him for this purpose out of the society funds.
