ORDER U/S 35 (5) OF DCS ACT, 2003


Whereas, Dhan Pothowar Co-operative Group Housing Society Ltd. is registered vide registration No.1414-GH with this department under the provisions of DCS Act & Rules and Bye-laws of the Society;

And whereas, complaint received from President, Vice-President, Treasurer & M.C. Member of the society vide letter dated 10.01.2020 (Copy enclosed) regarding resignation of Managing Committee of society (5 members out of 7 members) with request to disqualify all the members of the society who have not hold GBM every year in time and conduct audit of accounts well in time. Further take action on such members who have illegally hold the office managing committee during period from 14.01.2013 to 11.11.2018 and hold the election there after just to save their disqualification to seek the election for 06 years or more. Further pass any order which may deem fit & proper against the Managing Committee members for not compliance of Delhi Co-operative Societies Act, Rules & Bye-laws.

Now, I, Amitabh Joshi, Assistant Registrar (Sec-II/GH) hereby convey the approval of the Competent Authority to appoint **Mr. Suresh Chand, Section officer (Food & Supply)** as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Dhan Pothowar Co-operative Group Housing Society Ltd. (Regn. No.1414-GH) with immediate effect at the remuneration of **₹.10,000/-** (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) to be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period 90 days from the date of appointment as Administrator-Cum-Returning Officer.
