## **ORDER**

Whereas, Jaypee Co-operative Group Housing Society Ltd. Plot No 2 Sector-22 Dwarka, New Delhi-110077 is registered vide Registration No 654-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society

And, whereas, the last election of Managing Committee of the Society was held on 16 07 2017 and its term of 03 years was to expire on 15 07 2020.

And whereas, this office issued notification dated 25 06 2020 and subsequent corrigendum dated 09.07.2020 which says that-

"In all cases where the tenure of the Committee expires between 15th January, 2020 and 15th August, 2020 and where elections of the new committee of the society could not be conducted so far, the Committee shall arrange election of the new committee by 15th October, 2020 with date of polling falling between 1st September, 2020 and 15th October, 2020 and the tenure of the Committee of these societies would accordingly stand extended till the election of the new committee"

And whereas, the election of the new Committee of the Society have not yet been conducted and as per above notification the tenure of the Society stood extended up to 15th October, 2020 and now, RCS has appointed Sh. Amit Kumar Pamasi, Returning Officer in the Society vide this office order dated 18.09.2020.

And whereas, the tenure of the Managing Committee of the Society is ending on 15th October, 2020 as per notification and as per provision of section 35(5) of DCS Act, 2003, the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and the affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election.

Now therefore, I, Ajit Kumar, Assistant Registrar (SEC-III/GH) hereby convey the approval of the Competent Authority to appoint Sh. Amit Kumar Pamasi, Dy Director, Department of Welfare of SC/ST, Govt. of NCT of Delhi, as Administrator-Cum-Returning Officer w.e.f. 16th October, 2020 in Jaypee Co-operative Group Housing Society Ltd. (Regn. No.654-GH) under section 35 (5) of DCS Act, 2003 with immediate effect to conduct the election of the Managing Committee of the society which has already been notified vide agenda notice dated 05.10.2020 with date of polling on 01.11.2020.
