ORDER

Whereas, Jamna Bazar Co-operative Group Housing Society Ltd. Plot No. 28, Jamna Apartment, Sector-09, Rohini, New Delhi-110085 is registered vide Registration No.1440-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, the last election of the Management Committee of the Society was held in the Month of January 2020.

And, whereas, the President/Secretary (Interim Care Taker) of the Society vide letter dated 12.11.2020 informed this office that 11 elected members including Vice President of the Present Managing Committee of the Society have resigned during past few days and now, the strength of the elected Managing Committee members stands reduced to 04 members as on 07.11.2020 resulting in automatic pre-mature dissolution of the Management Committee.

And whereas, in view of the above facts and circumstances and to initiate the democratic process in the society as well as in the fitness of the things and in the better interest of the society, it will be appropriate to appoint an Administrator-cum-Returning Officer u/s 35 (5) of DCS Act, 2003 in the Society.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (Sec-III/GH) hereby convey the approval of the Competent Authority to appoint **Sh. Parvinder Singh, AAO, Directorate of Gurudwara Election**, as Administrator-cum-Returning Officer in Jamna Bazar Co-operative Group Housing Society Ltd. (Regn. No. 1440) under section 35 (5) of DCS Act, 2003 with immediate effect to conduct the election of the Managing Committee of the society within 90 days from the issue of this order and to the smooth functioning of the society. Administrator-Cum-Returning Officer will be paid 10,000/- (Rupees Ten Thousand Only) per month as honorarium from the society's fund for this purpose from the date of taking over the charge.

This issues with the prior approval of the Competent Authority.
