The Terms of Reference of the Committee shall be as under:-

- (i) The committee shall explore reform measures that improve ease of doing business in Delhi and shorten the process of economic recovery from the impact of COVID -19.
- (ii) The committee shall explore the possibility of renewal or automatic extension of existing licenses issued by various departments of GNCTD and local bodies i.e. Labour License, Shops and Establishment Registration, Contractor License, Nursing Home Registration etc. which stand expired after 01.03.2020 by a general order till 31.03.2021 without penalty / interest except categories such as excise, pollution control, fire where safety or revenue related issues are involved. While doing so, interests of labour should be protected.
- (iii) The committee shall explore the requirement / necessity of new licenses / NOCs issued by various department in order to identify the licenses which can be abolished or replaced with only prior intimation (in place of license). Similarly, the logical periodicity of renewal of licenses be studied and suggestions made on whether unnecessary Annual renewals need to be amended / abolished.

(iv) The committee shall explore if moratorium for some period can be provided in respect of lease payments, wherever possible.

- (v) The committee shall examine and identify the Services / Licenses provided by various departments of GNCTD, local bodies, which can be made available 'Online' or through 'Doorstep Delivery' in order to ensure scamless, contactless service to the public and businesses.
- (vi) The Committee shall particularly explore economic reform measures that have a potential for revenue mobilization for the Govt. of NCT of Delhi.
- (vii) The committee should explore international best practices that mega-cities and countries around the world are taking to enable economic recovery from COVID -19.
- (viii) The committee shall examine and suggest the penalties / fines or interest imposed on public / business due to COVID -19 pandemic, which can be waived off to remove undue financial hardship.
- (ix) The committee may also take up any other issue and suggest innovative measures to help people and businesses in distress.
