And whereas, SHOW CAUSE NOTICE were issued on 25/11/2019 & 31/12/2019 to the present owner and the previous owner of this vehicle Registration No. DL14CE 2840, as this office has noticed irregularities in transferring the ownership and hypothecation termination as detailed in the said SHOW CAUSE NOTICE (SCN) and these were returned back by the Postal Department with the remarks that "No such person" and this office has not received any Reply/Representation/ explanation/communication from you with reference to the SCN issued to you till this date. It seems that neither the present owner nor the seller of the vehicle reside at the addresses submitted in this office.

And whereas, it has been confirmed by the YES BANK that it has not issued NOC to the said vehicle DL14CE 2840 and submitted that the agreement of hypothecation of the vehicle continues and on prima facie it appears that the NOC and Form-35 for Termination of Hypothecation agreement documents of YES BANK submitted are false and the termination of hypothecation agreement has been done on the basis of documents which were, or by representation of facts which was, false in material particular and subsequently the ownership of the vehicle Registration No. DL14CE 2840 was transferred by Sh. Ankush Sharma in the name of of Sh. Ashish Kumar S/o Sh. Manoj Kumar, R/O of 217, Pocket 3, Sector 25 Rohini Rohini Sector 13 North West Delhi.

Now, therefore, I, Rakesh Kumar, (MLO) being the Registering Authority, Surajmal Vihar Zonal Office, hereby cancel the registration of the vehicle with registration no. **DL14CE 2840** under sub section 5 of Section 55 of MV Act 1988 for the reasons afore mentioned as the registration of the motor vehicle has been obtained on the basis of documents which were, or by representation of facts which was, false in material particular, with the directions to submit the original Registration Certificates of the vehicle immediately at this office.

Section 406: Punishment for criminal breach of trust—Whoever commits criminal breach of trust shall be punished with imprisonment of either description for a term which may extend to three years, or with fine, or with both.

**Note 2:** If you are aggrieved by this order, you may, within thirty days of the date of issue of this order, appeal against the order to the prescribed authority i.e. the Spl. Commissioner (Transport), Transport Department, Govt. of NCT of Delhi, 5/9, Under Hill Road, Delhi – 11054.
