Whereas, a vehicle with registration No. **DL14CD 8201 stands** Registered in the name of Sh. Atul Kumar, S/o Sh. Gulshan Kumar Sachdeva, R/o-93, Block-A, Pocket-3, Rohini, Sector-7, New Delhi – 110085 as per the records of this office.

And whereas, SHOW CAUSE NOTICES were issued on 29/11/2019 & 30/12/2019 to the registered owner of this vehicle Registration No. **DL14CD 8201**, as this office has noticed irregularities in the documents submitted for termination of hypothecation as detailed in the said SHOW CAUSE NOTICEs (SCN) and these were returned back by the Postal Department with the remarks that "No such person" and this office has not received any Reply/Representation/ explanation/communication from you with reference to the SCN issued to you till this date. It seems that you do not reside at the address submitted for the purpose of registration of the vehicles in this office.

And whereas, it has been confirmed by the ICICI BANK that it has not issued NOC to the said vehicle **DL14CD 8201** and submitted that the agreement of hypothecation of the vehicle continues. On prima facie it appears that the NOC and Form-35 for Termination of Hypothecation agreement documents of ICICI BANK submitted are false and on the basis of documents which were, or by representation of facts which was, false in material particular.

Now, therefore, I, Rakesh Kumar, (MLO) being the Registering Authority, Surajmal Vihar Zonal Office, hereby cancel the registration of the vehicle with registration no. **DL14CD 8201** under sub section 5 of Section 55 of MV Act 1988 for the reasons afore mentioned as the registration of the motor vehicle has been obtained on the basis of documents (fake Address proof and forged NOC and Form-35) which were, or by representation of facts which was, false in material.

Section 406: Punishment for criminal breach of trust—Whoever commits criminal breach of trust shall be punished with imprisonment of either description for a term

which may extend to three years, or with fine, or with both.

Note 2: If you are aggrieved by this order, you may, within thirty days of the date of issue of this order, appeal against the order to the prescribed authority i.e. the Spl. Commissioner (Transport), Transport Department, Govt. of NCT of Delhi, 5/9, Under Hill Road, Delhi – 11054.
