Show Cause Notice

Sub: Immovable property for the year end 31st Dec 2018 in r/o Group-B officers.

Whereas, as per the provisions of Rule 18 of CCS (Conduct) Rules, 1964, every government servant belonging to any service holding any post included in Group 'A' and Group 'B' shall submit her/his Annual Property Return for the calendar year in the month of January of following year on the prescribed proforma giving full particulars regarding immovable property inherited by her/him or owned or acquired by her/him on lease or mortgage either in her/his own name or in the name of any member of her/his family or the name of any other person.

And whereas, instructions in this regard were circulated to all officers of DWCD vide circulated No. F.13(14)/DWCD/Vig./Misc./2017/42194-313, dated 29.12.2017 under the signatures of the then Dy. Director (Vig.) seeking strict compliance.

And whereas, vide office order F.No.09(131)/Misc./Admn/WCD/2014/2801-23 dated 06.05.2019 all Group-B Gazetted officers were directed to submit Annual Immovable Property for the year ended-2018. Due to non-compliance of the said orders, a subsequent order bearing No. 09(131)/Misc./Admn/WCD/2014/20534-37, dated 10.12.2019 was issued requiring the Group-B Gazetted Officers of DWCD to submit the Annual Immovable Property for the year ended-2018, within as time frame of 10 days of the receipt of the order along with explanation for non-submission of the same within stipulated time period besides they were also warned that disciplinary proceedings shall be initiated against the officers who fail to comply with direction to submit their Annual Property Return within time.


And whereas, despite above directions & mandate of CCS (conduct) Rules, 1964, the following **Group-B officers** have not submitted their statement of the immovable property for the year ending-2018 till date:-
