ORDER

Whereas, it has been proved that work and conduct of Smt. Dikssha, Protection Officer (Contractual) presently working in District Officer (North East) WCD was not satisfactory with serious lapses of dereliction of duty, not appearing in the court against notices issued by the Court of MM, Karkardooma Court, Delhi since 11.10.2019.

And whereas, on 13.10.2019 Ms. Dikssha, Protection Officer (Contractual) was called by District Officer (NE) telephonically and through phone/ messages for appearance on 14.10.2019 against the notice/ summon issued by the court, but she did not answer to the call.

And whereas, an application was forwarded by Ms. Dikssha on dated 11.10.2019 via Whatapp for one year leave without pay or to accept her resignation letter.

And whereas, the conduct of Ms. Dikssha, Protection Officer (Contractual) is highly objectionable and unwanted because the same is not permissible under the rules. This clarify reflects lack of devotion/ dedication and dereliction towards her duties.

And whereas, the conduct of Ms. Dikssha, PO for tendering resignation through whatapps and immediately stopping attending her duties are clear violation of Rules No. 6 of her job agreement with the Department

Now, therefore, the Competent Authority has decided to terminate the services of Ms. Dikssha, Protection Officer (Contractual) from 11.10.2019 and also to recovered one month salary from her.

The issues with the approval/direction of HOD vide D.O. No. 425 dated 06.02.2020.
