Whereas, Smt. Sharanjeet Kaur, is engaged with DWCD as a Welfare Officer on contract basis and is physically posted at District Officer (North-West-II), WCD.

And whereas, Smt. Saranjeet Kaur applied for 13 days Earned Leave, which was granted to her in the month of August i.e. from 19.08.2019 to 31.08.2019 and she was supposed to join her duties on 02.09.2019.

And whereas she did not join her duties and prepared electronics communication (e-mail) for the further extension of leaves on medical grounds.

The Medical Certificate sent by her was not bearing her signature and even the exact period of bed rest advised to her was not mentioned in the medical certificate. Therefore the same cannot be treated as authentic.

And whereas, the conduct of Smt. Saranjeet Kaur, Welfare Officer, (Contractual) is found to be highly objectionable and unwanted because the same is not permissible under the rules. This clearly reflects lack of devotions, dedication and dereliction towards duties.

And whereas, her conduct is also found violative of the contractual condition (6) vide letter of offer of engagement on contract basis.

Now, therefore, considering above mentioned lapses on the part of Mrs. Saranjeet Kaur, Welfare Officer (Contractual), the Competent Authority has decided to terminate her services with DWCD of Welfare Officer with immediate effect.
