## ORDER

In continuation to order NO.F.76(554)/creation of post under NNM/DWCD/ICDS/2018-19/1161-70 dated 16-04-2019, sanction of competent authority is hereby conveyed for continuation of 225 numbers of regular/contractual posts of various categories under Centrally sponsored National Nutrition Mission (NNM) for POSHAN ABHIYAAN <u>w.e.f. 01-04-2020 to 31-03-2021</u> to implement in 11 District of NCT of Delhi under DWCD. The details of the posts which are being continued are as under:-

The above posts are already approved by the Government of India under Poshan Abhiyaan(Centrally sponsored Scheme) and funds to the tune of 80% for salary expenditure of these posts is to be borne by GOI and 20% by State Government as per pattern of 80:20.

As per recommendations of GOI to run the ICDS on Mission Mode the Department had created 300 posts of different categories with approval of the Hon'ble Lt. Governor vide order dated 31.08.2016. Since the contractual posts so created were not filled and GOI discontinued them w.e.f. 01.04.2017 as such now, it was proposed to create the posts as approved by GOI for POSHAN Abhiyaan by surrendering the 296 contractual posts (excluding 02 regular posts of Director-ICDS and Joint Director-ICDS).



The posts/contractual/outsourced personnel approved vide this order will be over and above the posts already sanctioned for State/Districts Cells and for ICDS Projects and the creation shall be valid subject to funds being provided by Govt. of India/Govt. of Delhi for the purpose for which posts are created.

Hon'ble Lt. Governor, Delhi vide Raj Niwas Diary no. 32981 dated 27.02.2019 has already approved above mentioned 223 posts of various categories on contractual basis. Earlier the Finance Department vide their U.O. No. DSF-V/177 dated 16.01.2019 have already concurred the same.

The above extension of posts is subject to following conditions:-

- 01. That budget/funds are released by Government of India for the ICDS Projects,
- 02. That provision of funds to meet the expenditure on salary and allowance/honorarium of the staff is made in the relevant Budget head of the scheme.
- 03. Posts are required for due discharge of the duties for implementation of the project during the relevant period for which the continuation is approved.
- 04. The Project for which the posts are created remain operational during the relevant period.
- 05. The order is valid in respect of the posts which are not lying vacant for more than one year or the posts which remain vacant for more than one year and subsequently revived by the competent authority from time to time.
- 06. In respect of abolished posts of UDCs, the present incumbents shall draw their salary against the vacant posts of Assistant/Statistical Assistant till further orders or till Asstt./St. Assistants joins the posts.
- 07. Compliance of all codal formalities under GFR, 2017 and all guidelines issued by the GOI & GNCTD from time to time and also subject to availability of funds.

Expenditure involved on meeting the expenditure on salary & allowances and honorarium in respect of above posts shall be debitable to respective Head of Accounts of ICDS i.e. (General) CSS(Plan)-2235 02 102 55 0042; ICDS (General) State Share (Plan) 2235 02 102 29 0042 and Honorarium to Anganwari Workers and Helpers-2235 02 102 38 0042 for the Financial year 2020-2021
