ORDER

Sub: Status of MACP cases in r/o Ex-Cadre Teaching Staff of WCD.

All the concerned DDOs/HOOs of the Department are hereby informed that MACP cases in r/o Ex-Cadre Teaching Staff of WCD (as received from time to time) have been scrutinized, status of which is compiled in a list as "**Annexure-A**" which is **enclosed** herewith this order, as such, all the DDOs/HOOs of the Department are hereby directed to go through the information contained in the "**Column-5 (Remarks)**" of the said "**Annexure-A**" and to **make compliance of the following directions**, as under :-

- (a) All concerned DDOs/HOOs are directed to first fix the pay in r/o **Ex-Cadre Teaching Staff** (mentioned at **S.No. 1 to 4** of the said **Annexure-A**) as per the directions of Order dated 23.01.2020 issued by Hon'ble High Court of Delhi in W.P.(C) 4034/2014 in the matter of "Krishna Kumari and Ors Vs Union of India Vs Ors" and record necessary entries upto date in their Service Book and then, submit their MACP cases alongwith Service Books and all requisite documents to the Admn. Branch (WCD) strictly as per the guidelines prescribed in the Order No. F.9(206)/Admn/WCD/MACP/2020/PartFile-II/25305-24 dated 17.02.2020 (**copy of the said order dated 17.02.2020 is available on the website of WCD**).
- (b) All concerned DDOs/HOOs are advised to wait till the discrepancies in the pay scales of Ex-Cadre Teaching staff gets sorted out by the Ministry of Home Affairs, GOI and then submit the MACP cases alongwith Service Book and all requisite documents in r/o **Ex-Cadre Teaching Staff** (mentioned at **S.No. 5 to 10** of the said **Annexure-A**), to the Admn. Branch (WCD) strictly as per the guidelines prescribed in the Order No. F.9(206)/Admn/WCD/MACP/2020/PartFile-II/25305-24 dated 17.02.2020 (**copy of the said order dated 17.02.2020 is available on the website of WCD**).

Ministry of Home Affairs, Govt. of India vide its letter No. 14012/23/2019-Delhi-I dated 12.03.2020 has raised some queries and has sought some information relating to pay scales and recruitment rules of the Ex-Cadre teaching staff. WCD has made several communications vide letter dated 12.02.2020, 12.03.2020 and email dated 02.07.2020 with the Admn. Branch, Department of Social Welfare, GNCTD with the request to provide "Certified copies of Recruitment Rules (RRs) of Ex-Cadre Teaching posts of WCD, so that based on such information, reply could be furnished to the Ministry of Home Affairs, GOI for further necessary action. However, till date the requisite documents have not been received from the Department of Social Welfare, GNCTD. Note : While submitting Action Taken Report to the OSD to Hon'ble Minister (WCD), GNCTD vide letter No. F.17(17)/WCD/Admn/Teaching/PayFixation/2018/3632-36 dated 27.07.2020, a copy of said letter was also endorsed to the Deputy Director (Admn), Department of Social Welfare, GNCTD, for providing the requisite documents/ information, immediately.
