And whereas, Ms. Akansha, Welfare Officer was transferred to Children Home for Girls, Nirmal Chhaya vide order No. F.76(362)/DWCD/ICDS/2013-14/Pt. File/14184-85 dated 25.11.2019. But she was not coming to CHG-I, Nirmal Chhaya from November, 2019 around 05 months are over and she has not informed the Supdt., Nirmal Chhaya about her leave.


And whereas, in response to Show Cause Notice she had moved to Varansi in the month of March, 2020 without informing the respective office which is objectionable, as no leave or information of outstation leave had been given by her.

And whereas, the conduct of Ms. Akansha, Welfare Officer (Contractual) is found to be highly objectionable and unwanted because the same is not permissible under the rules, This clearly reflects lack of devotion, dedication and dereliction towards duties.

And whereas, in offer letter clear mentioned that "any unauthorised absence from duty for more than five days will lead to termination of the contract."

Now, therefore, considering above mentioned lapses on the part of Ms. Akansha Sharma, Welfare Officer (Contractual), the Competent Authority has decided to terminate her services with DWCD of Welfare Officer with immediate effect.
