ORDER

Whereas, **Ms. Asha Gandhi, Sr. Supdt.** vide letter dated 09.07.2020 (bearing Diary No. 5235/DD-A dated 13.07.2020) had tendered voluntary retirement (VRS) due to domestic and medical reasons and has requested to treat the said request letter as a Notice period starting from 10.07.2020.


Whereas, vide letter No. F.OS(Admn)/22/WCD/2010/3329-30 dated 21.07.2020, the Supdt./DDO/HOO, CHB-I, Alipur was directed to provide requisite documents in r/o the officer i.e. Proformas for seeking Vigilance Clearance (both Departmental & DOV), attested copy of first page of Service Book and attested copy of UID/Aadhaar Card. And the same had been received from the Supdt./DDO/HOO, CHB-I, Alipur vide letter No. F.1(CHB)-1/2020-21/309 dated 30.07.2020.

Whereas, her Vigilance Clearance Status were sought from Vigilance Branch (WCD) and Directorate of Vigilance (DOV), GNCTD vide letter No. F.OS(Admn)/22/WCD/2010/1212 dated 07.08.2020 and letter No. F.OS(Admn)/22/WCD/2010/4378 dated 07.08.2020, respectively. And the same have been received from the Vigilance Branch (WCD) and Dte. of Vigilance (DOV), GNCTD vide letter No. F.12(1)/Vig./WCD/ 2016/PF-IV/113 dated 11.08.2020 and letter No. F.99/7/2020/DOV/II/6311 dated 21.08.2020, respectively stating that – "**no vigilance case/disciplinary proceeding contemplated/pending against the officer as on date**".

Whereas, she has submitted a request letter dated 08.09.2020 (bearing Diary No. 5991/DD-A dated 08.09.2020) vide which she has requested for extending her VRS date upto 31st Nov, 2020 and has requested to consider her first day of notice period of Voluntary Retirement from 2nd Sep, 2020 and ended upto 30th Nov, 2020. Subsequently, she submitted another request letter dated 23.09.2020 (bearing Diary No. 6279/DD-A dated 30.09.2020) vide which she has requested to allow her to take back her request of VRS with immediate effect.

Whereas, her above referred request dated 23.09.2020 has been placed before the Director (WCD) and has been considered and accepted, as such, it is hereby ordered that above referred request dated 09.07.2020 and subsequent request dated 08.09.2020 for Voluntary Retirement stands **withdrawn**.


