
ORDER

All Food Safety Officers are advised to check and verify their residential address. Any change in this regard may be conveyed to the Administration Branch. They should display their name plates.


All the Food Safety Officers are required to seal the VIP sample at the time of lifting. No sample will be accepted by the Food Analyst in loose condition without proper sealing.
