Therefore, in compliance of Hon'ble High Court interim order dated 27.05.2019, Your appointment to the post of **Lecturer (Plastic Technology)** shall be subject to the outcome of the present petition, as directed by Hon'ble High Court, Delhi in W.P.(C) 5919/2019
