Consequent upon selection to the post of Vice Principal (ITIs Asstt. Inspector of Training/Industrial Liaison Officer-cum Officer in charge/Training Officer) by the Union Public Service Commission and after having been declared medically fit for entry into Govt. Service by the Civil Surgeon/ Medical Officer, Sanjay Gandhi Memorial Hospital, Delhi, the Hon'ble Lt. Governor, Delhi is pleased to appoint Mr. Manish Kumar Thakur to the post of Vice Principal purely on provisional basis in the pay scale of Rs. 56100-177500/- Dearness and other allowances as admissible under the rules in force from time to time, on the terms and conditions laid down in the offer of appointment and accepted by him.

Inspector of Training/Industrial Liaison Officer-cum Officer in charge/Training Officer) shall be subject to the outcome of the present petition, as directed by Hon'ble High Court, Delhi in W.P.(C) 5919/2019.
