Reference: Regarding Examination for the Regular & Back/Compartment students for Odd semester diploma level examination-Jan/Feb-2022 at home Institute level.

It is to inform to all concerned Institutes/Polytechnics that Odd Semester Diploma Level Examination Jan/Feb-2022 for students (including regular students for 3rd, 5th & 7th (part time) semester including having back/compartment and Ist & IInd year for pharmacy and trade diploma courses of eligible students i.e. Exstudents/left out students/failed students) will be held at the home Polytechnics/Institutes (Govt./Govt. Aided/Private) of the students as per schedule given below:-

Commencement of Theory Exam- 5 th & 7 th (part time) semester	
Commencement of Practical Exam- 5 th & 7 th (part time) semester	17/01/2022 to 24/01/2022
Commencement of Theory Exam-3 rd semester including lateral entry	01/02/2022 to 11/02/2022
Commencement of Practical Exam-3 rd semester including lateral entry	14/02/2022 to 21/02/2022

Both theory and Practical examinations for regular & back/ compartment will be conducted at the home institutes of students and therefore, concerned subject faculty of concerned institute will prepare question papers on their own level as per BTE pattern, syllabus/norms for theory examinations. No remuneration will be paid for Paper Setting/Moderation/Translation of question paper.

Evaluation of theory answer sheets will also be done at institute level by the concerned subject faculty and only final award lists will be forwarded by the institute online as well as hard copy to the BTE within three days after completion of examination.

Further, Principals of all the institute/polytechnics must ensure that examinations and evaluation work of answer sheets must be done under the surveillance of CCTV Cameras.

Further, Admit cards already issued to the students will be valid for above mentioned rescheduled examination at home level institute and Left out students who could not submit the examination form, are hereby directed to submit the examination form by 03/01/2022 for 5^{th} & 7^{th} (part time) semester and 31/01/2022for 3rd semester including lateral entry.

For conducting examinations, Principals of all the institute/polytechnics must ensure that social distancing shall be maintained in each and every examination hall/room and all the staff of the institute & students appearing in the examination must wear face mask during examination. Hand sanitizer must also be available in each and every examination hall/room in the institutes and other guidelines issued by authorities of Govt. of India and Govt. of NCT of Delhi time to time regarding Covid-19 shall be followed strictly.
