FIRE SAFETY CERTIFICATE

Certified that the M/s Hotel Royal Palace located at 1056-59, Pai Walan, Jama Masjid, Delhi, comprised of **Ground + 03 upper floors: Ground floor– reception, 1st floor to 3rd floor – 06 guest rooms at each floor level & 02 temporary store room at terrace floor, total 18 guest rooms** was granted FSC by this department vide letter no. F6/DFS/MS/GH/2017/377 dated 08.03.2018. The building/premises was re-inspected by Assistant Divisional Officer (SPM) from this department on 12.02.2021 in presence of Manager, and found that now the building is comprised on **ground + mezzanine + 04 upper floors: ground floor- reception, Mezzanine – office (sealed), 1st floor to 3rd floor -06 guest rooms at each floor, terrace/4th floor -02 rooms- vacant and not in use.** The owner has submitted an affidavit stating that they have sealed the mezzanine floor and shall not use any floor above third floor for any purpose in accordance with Gazette Notification dated 27.05.2019 and its subsequent clarification dated 25.09.2019 and 17.12.2021. The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy of **“Group A-1 (Residential)”** for total **18 guest rooms (Ground floor - reception, 1st floor to 3rd floor -06 guest rooms at each floor)** only, with effect from18/2/21..... for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire service Rules, 2010 printed below.

Condition for the validity of fire safety certificate

1. **This clearance/FSC shall stand cancelled if guest house owner/occupier fails to comply all other conditions mentioned in the gazette notification dated 27.05.2019 and any violation of clarification issued on 25.09.2019 & 17.12.2020 latest by 31.03.2021**
2. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
3. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
4. The trained fire fighting staff should be available round the clock.
5. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
7. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (1) of Rule 37] along with a copy of this Certificate, six month prior to its expiry".Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained there to before occupancy of the same.



F6/DFS/MS/GZH/NDZ/2021/98 dated 27.01.2021 has been rectified by the management of the guest house and the owner has submitted an affidavit stating that the mezzanine floor has been sealed and any floor above third floor shall not be used for any purpose in accordance with Gazette Notification dated 27.05.2019 and its subsequent clarification dated 25.09.2019 and 17.12.2021.

In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter No. F6/DFS/MS/GH/2017/377 dated 08.03.2018 is recommended to be renewed for ground 1st, 2nd and 3rd floor only, under Rule 35 of the Delhi Fire Service Rules 2010.


