Covered area of the restaurant is 798m<sup>2</sup> and as per NBC (Part-IV) the no. of occupants comes out to be Approx. 443 (798/1.8=443.33). Thus capacity of restaurant is 443 persons which is covered under DFS Act 2007, Rules 2010.

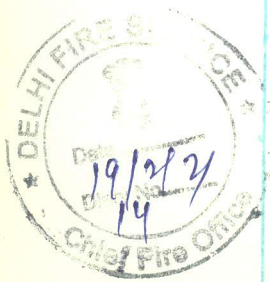
The fire protection systems provided in the building were tested, checked and found functional at the time of inspection.
