**FIRE SAFETY CERTIFICATE**

Certified that the M/s Metro Guest House, 639, Churiwalan, Jama Masjid, Delhi-06, comprised of **Ground + 03 upper floors: Ground floor** – commercial use, **1<sup>st</sup> floor** – 06 guest rooms, **2<sup>nd</sup> floor** -06 guest rooms, **3<sup>rd</sup> floor** – 04 guest rooms **total 16 guest rooms** was granted **FSC** by this department vide letter no. F6/DFS/MS/GH/NDZ/2018/924 dated 04.05.2018. The building/premises was re-inspected by Assistant Divisional Officer (SPM) from this department on 12.02.2021 in presence of owner Md. Hafiz Akram Zamal and found that the building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy of “**Group A-1 (Residential)**” for total **16 guest rooms** (**1<sup>st</sup> floor** – 06 guest rooms, **2<sup>nd</sup> floor** -06 guest rooms, **3<sup>rd</sup> floor** - 04 guest rooms) only, with effect from .....18/02/2021..... for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire service Rules, 2010 printed below.



**Condition for the validity of fire safety certificate**

1. **This clearance/FSC shall stand cancelled if guest house owner/occupier fails to comply all other conditions mentioned in the gazette notification dated 27.05.2019 and any violation of clarification issued on 25.09.2019 & 17.12.2020 latest by 31.03.2021**
2. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
3. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
4. The trained fire fighting staff should be available round the clock.
5. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
7. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in)
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry".Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained there to before occupancy of the same.

The guest house had been initially issued FSC for 36 guest rooms vide letter no. F6/MS/DFS/GH/08/2770 dated 01/10/08 which was later converted to 16 guest rooms in FSC issued vide letter no. F6/DFS/MS/GH/2015/NDZ/309 dated 05/03/15 onwards. During the inspection dated 12.02.2021 it was noticed that the existing extra rooms (rooms other than 16 guest rooms as mentioned in the previous FSC issued vide letter no. F6/DFS/MS/GH/NDZ/2018/924 dated 04/05/2018) are being used by the owner for other purposes. Owner has also submitted an affidavit regarding floor wise occupancy of the premises also stating that there has been no addition alteration in the building ever since the Guest house is running in the building.

The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspections.

In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter No. F6/DFS/MS/GH/NDZ/2018/924 dated 04.05.2018 is recommended to be renewed under Rule 35 of the Delhi Fire Service Rules 2010.


