**FIRE SAFETY CERTIFICATE**

Certified that the M/s Mustafa Guest House, located at 3933, Urdu Bazar, Jama Masjid, Delhi, comprised of **Ground + 04 upper floors: Ground floor**– reception + 03 guest rooms, **1<sup>st</sup> floor**- 01 Hall, **2<sup>nd</sup> floor** - 02 guest rooms, **3<sup>rd</sup> floor** - 02 guest rooms, **4<sup>th</sup> floor** – 01 guest rooms (not in use) **total 08 guest rooms and 01 Hall** was granted FSC by this department vide letter no. F6/DFS/MS/GH/2017/NDZ/1532 dated 24.10.2017. The building/premises was re-inspected by Assistant Divisional Officer (SPM) from this department on 11.02.2021 in presence of Manager, and found that the owner had demolished the 5<sup>th</sup> floor and now the building is comprised of **ground + 04 upper floors: ground floor**- reception + office + 02 guest rooms, **1<sup>st</sup> floor** – 01 Hall + 02 stores, **2<sup>nd</sup> floor** – 02 guest rooms + 02 stores, **3<sup>rd</sup> floor** -02 guest rooms + 02 stores, **4<sup>th</sup> floor** -not in use (closed). The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. The owner has submitted an affidavit dated 12.12.2019 not to use any floor above third floor for any purpose in accordance with Gazette Notification dated 27.05.2019 and its subsequent clarification dated 25.09.2019.. Accordingly, the premises is fit for occupancy of “**Group A-1 (Residential)**” for total **06 guest rooms + 01 Hall (Ground floor** - reception + 02 guest rooms, **1<sup>st</sup> floor**- 01 Hall, **2<sup>nd</sup> floor** - 02 guest rooms, **3<sup>rd</sup> floor** - 02 guest rooms) only, with effect from .....18/2/21..... for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire service Rules, 2010 printed below.



**Condition for the validity of fire safety certificate**

1. **This clearance/FSC shall stand cancelled if guest house owner/occupier fails to comply all other conditions mentioned in the gazette notification dated 27.05.2019 and any violation of clarification issued on 25.09.2019 & 17.12.2020 latest by 31.03.2021**
2. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
3. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
4. The trained fire fighting staff should be available round the clock.
5. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
7. The owner / occupier shall submit a declaration every year in form ‘K’ provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in)
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form ‘J’ [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry”.  
Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained there to before occupancy of the same.

The height of the building as submitted by North Delhi Municipal Corporation vide letter no. EE(B)-II/ CSPZ/2020/D-1313 dated 14.01.2020 was 16.95 meters for ground + 5 upper floors. During the inspection dated 11.02.2021 it was found that the owner had demolished the 5<sup>th</sup> floor and now the building is comprised of ground + 4 upper floors for which the previous FSC dated 24.10.2017 had been granted.

The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspection.

The owner has submitted an affidavit on 28.12.2019 not to use any floor above third floor for any purpose in accordance with Gazette Notification dated 27.05.2019 and its subsequent clarification dated 25.09.2019.

In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter No. F6/DFS/MS/GH/2017/NDZ/1532 dated 24.10.2017 only upto 3<sup>rd</sup> floor is recommended to be renewed under Rule 35 of the Delhi Fire Service Rules 2010.
