Please refer to your letter dt.30.06.08on the subject cited above. In this regard, it is to inform you that the officer concerned with respect to the circular no.262-362 dated17.01.2005 (issued by the Director of Education), carried out the inspection of the above said premises from fire safety angle. The school building is comprised of, ground plus three upper floors is not accessible for fire vehicle. At the time of inspection Mr.Sanjay Kumar was present. During the inspection the following points/shortcomings were observed-

- 1.ISI marked fire extinguishers of various capacities, CO2 type ABC Type were not provided.
- 2.Down comer system with proper landing valves, hose boxes with proper delivery hoses and branch pipe at each level was not provided.
- 3. First aid hose reels at each level were not provided.
- 4. Overhead tank of 5000 lts. on terrace connected with fire Pump Cap. 450 lpm with 40 mtrs head and Jockey pump cap. 180 lpm with 40 mtrs head was not provided.
- 5. Manual alarm was not provided.
- 6. Alternative means of escape i.e second staircase was not provided.

In view of above observations the NOC/fire clearance for the school building can not be considered in the interest of the student/occupant's safety, at this stage .The authority concerned are suggested to comply with all the fire safety recommendations as circulated/issued by the Director of Education as per above said circular, under the intimation to this department for further course of action.
