
- 1. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.

The fire protection systems provided in the building were randomly tested, checked and found functional at the time of inspection.

Further, the department has already issued a FSC for storage of fireworks at shop no. 10104 area of admeasuring 13.85SQM vide letter No F6/DFS/MS/NDZ/2018/4156 dated 04.10.2018(copy placed on file at C/51.

Now, the letter has been received from ACP /A & E regarding issuance FSC to additional land i.e 10103 & 10105 adjacent to existing shop. Accordingly, the site was inspected by ADO (CC) on dated 16.08.21 and observed that the building is comprised of ground floor having shops at ground floor (13.85 m2 (existing)+ 10.14 m2(proposed) = 23.99 m2 for storage of fire crackers. and fire safety arrangements as mentioned above are placed on the site.

In view of the compliance of the minimum standards of fire prevention and fire safety measures as required under the rules, if agreed, the FSC issued vide letter no. F6/DFS/MS/NDZ/2018/4156 dated 04/10/2018, renewal under guidelines issued by Addl. Commissioner of Police (Lic.), is recommended for approval.
