Note : The height of this building had been declared as 16.05 meters (high rise) by PWD vide letter no. EE(B)-II/CSPZ/2020/D-1316 dated 14.01.2020 (placed at C/82). However the Guest House management has already submitted an affidavit dated 17.01.2020 stating not to use any floor above 3^{rd} floor for any purpose in accordance with Gazette Notification dated 27.05.2019 and its subsequent clarification dated 25.09.2019 and the 4^{th} floor was found locked at the time of inspection. The height of the building upto 3^{rd} floor is evidently below 15 meters. Hence operation of the guest house may be considered upto 3^{rd} floor. The owner has also complied with the additional fire safety requirements as mentioned in the said Gazette notification.

The shortcomings issued by this department vide letter no. F6/DFS/MS/GH/NDZ/2019/7504 dated 16.12.2019 has been rectified by the management.

The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspection.

If agreed and in view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F6/DFS/MS/GH/NDZ/2018/2155 dated 19.09.2018 is recommended to be renewed under Rule 35 of the Delhi Fire Service Rules 2010 upto 3rd floor only.
