- 3. That the engagement may be terminated at any time by a month's notice by either side viz, by the appointee or the appointing authority without assigning any reason.
- 4. That if he/she remains absent from duty for more than 30 days without any information/permission his/her service are liable to be terminated.
- 5. That the individual will perform the duties of the post offered to him/her to the best of his/her ability and to the satisfaction of superiors/department.
- 6. That his/her engagement is subject to the satisfactory, work & conduct during the period of service to the entire certification of his/her Controlling Officer
- 7. That the engagement to the post of Beldar on Muster Roll is subject to the verification of my educational and caste certificate from the concerned University/School/ College/ Board/ Institution/ Department/ Authorities concerned, Character and past antecedents by the police authorities and further subject to medical fitness and in case the report are not found favorable, the service of individual be terminated without assigning any reason.
