Subject: **Reimbursement of OPD-Medicines: Special-Sanction in view of COVID-19.**

This is in continuation to this Office OM of even number dated: 28-08-2020 followed by OM dated: 02-06-2020, on the above quoted subject, based on G.O.I., Ministry of Health & Family Welfare (Directorate General of CGHS)'s OM No. Z.15025/ 12/ 2020/ DIR/ CGHS dated: 27-03-2020 and dated: 29-04-2020, 29-05-2020 & 24-08-2020 vide which DJB Beneficiaries, suffering from Chronic-diseases/ whose treatment is already decided and who are required same medicines for longer-period, were permitted to purchase medicines based on the prescription already held (prescribed by DJB Medical-Officer/ Specialists of Govt./ Panel Hospitals) from market till 30st September 2020, irrespective of Non-availability Certificate of DJB Dispensaries.

Now, in continuation to OM of even number dated: 27-03-2020 and dated: 29-04-2020, G.O.I., Ministry of Health & Family Welfare (Directorate General of CGHS), vide its OM No. Z.15025/ 12/ 2020/ DIR/ CGHS dated: 29-05-2020 & 24-08-2020, has in view of continued 'Lockdown' now extended the permission till 31st December 2020, on same conditions as contained in its earlier OM dated: 27-03-2020.

The matter has been placed before the Competent-Authority of D.J.B., who vide his Order dated: 05-11-2020, has accorded Approval of extending the permission till 31-12-2020, on same conditions as contained in this Office's earlier OM dated: 28-08-2020.
